SETTLEMENT AGREEMENT

- 2. As such, Florida Housing will withdraw its "Argument in Opposition to Recommended Order," filed on March 25, 2009.

- 3. In turn, Fountain Terrace will withdraw its "Motion to Strike Respondent's Argument in Opposition to Recommended Order," filed on June 3, 2009.
- 4. Florida Housing will recommend that its Board of Directors adopt as its own the Findings of Fact, Conclusions of Law, and Recommended disposition of the Recommended Order filed on March 20, 2009, and issue a Final Order consistent with its adoption of the Recommended Order.
- 5. Upon issuance of such Final Order, Florida Housing agrees to provide Fountain Terrace with "the next available funding," as provided in Rule 67-48.005(7), Fla. Admin. Code.
 - 6. Each party will bear its own attorneys' fees and eosts.
- 7. The parties agree that all issues raised in the above-captioned case shall be fully resolved and will waive any further administrative proceedings and appeals as to such issues upon adoption of this Settlement Agreement and entry of the contemplated Final Order by Florida Housing's Board of Directors.

WHEREFORE, Florida Housing and Fountain Terrace request that the Board of Directors accept and adopt this Settlement Agreement and enter a final order in this matter accordingly.
