Developers are already having a hard enough time closing family or elderly 9% deals that do not include special requirements. By adding the complexity and costs of an ALF to the deal, it will most likely significantly delay the delivery of affordable units in our State. We would recommend that FHFC use bonds, SAIL, and 4% credits for this type of community.
