Line 82	Note 1 - Line 35 does not equal Line 76 because repayments were received, by check or by EFT, into Florida Housing's operating account and not yet transferred to BNYM. During the quarter, \$1,479,032.17 in
Line 83	previous receipts were transferred to BNY. Additionally, \$1,441,718.37 of the repayments collected in the current quarter had not been transferred to BNYM by quarter end. Treasury's security interest in
Line 84	the repayments is mainly protected by approximately \$1.25 million in expenses advanced by Florida Housing during the quarter. The remaining amount due to BNYM (\$228,813.21) was transferred in
Line 85	November.

Line 87	Note 2 - Lines 7(d)-18(d) do not equal Line 39(g) because of \$33,000.00 returned by servicers to Florida Housing's operating account during the quarter. Because these are not yet in the BNY Mellon HHF
Line 88	account, they are not yet reflected on lines 7(d) - 18(d) or on line 79. The total is made up of seven receipts from five different servicers.
