#### **MINUTES**

#### **AUDIT COMMITTEE UPDATE**

Mario Facella stated that the Audit Committee met on January 20, 2022, and approved the 2022 Office of the Inspector General and Audit Committee charters. He reported that Ernst & Young presented their plans for the 2021 financial audit of the corporation. He reported that the Committee also discussed the evaluations of the Inspector General and Executive Director.

## **LEGAL**

<u>Item A – HTG Oasis, LLC v Florida Housing Finance Corporation, Lofts on 36, Ltd., and Coco Palm Place, LP.</u> Hugh Brown asked the Board to adopt the findings of fact, conclusions of law and recommendation of the recommended order and issue a final order accordingly in the HTG Oasis, LLC v Florida Housing Finance Corporation, Lofts on 36, Ltd., and Coco Palm Place matter.

Motion to approve staff's recommendation was made by Mr. Motwani with a second by Ms. Einhorn. The motion passed unanimously.

#### **MULTIFAMILY PROGRAMS**

<u>Item A, 2022 Rule Development</u>. Marisa Button asked the Board to authorize staff to proceed with 2022 rule development.

Motion to approve staff's recommendation was made by Mr. Benson with a second by Ms. Einhorn. The motion passed unanimously.

Item B, Development of RFA to Pilot Financing of Permanent Supportive Housing in Concert with State Behavioral Healthcare Services Funding. Marisa Button asked the Board to approve the implementation of the pilot program to finance permanent supportive housing in concert with state behavioral healthcare services funding through a development workshop and issuance of an RFA, and to approve the estimated reservation of the resources required.

Motion to approve staff's recommendation was made by Mr. Benson with a second by Ms. Einhorn. The motion passed unanimously.

### **POLICY**

Item A, Allocation Plan for the Home Investment Partnerships Program (HOME) Funded Through the American Rescue Plan Act (HOME-ARP). Bill Aldinger asked the Board to approve the allocation plan for the Home Investment Partnerships Program funded through the American Rescue Plan and staff's request to work with the Department of Economic Opportunity to submit the application plan to HUD as part of the substantial amendment to the Florida consolidated plan.

Motion to approve staff's recommendation was made by Ms. Einhorn with a second by Mr. Hall. The motion passed unanimously.
