- 2. <u>Owner is required to annually submit to Florida Housing audited financial</u> <u>statements, Financial Reporting Form SR-1 and a certification as to the</u> <u>accuracy of the financials.</u>

have SAIL, RRLP, TCAP, or HOME funds, you may be in Group 1)

- DUE: Annually
 - No later than May 31 or 151 days after applicant's fiscal year end.
 - Refer to regulatory documents to determine when initial report is due.
- LATE FEE: \$500
- ITEMS TO SUBMIT:
 - Parts 1through 5, <u>Financial Reporting Form (SR-1) (Rev. 01/23)</u>, Excel format; Do <mark>NOT</mark> use older forms
 - Executed Certification, PDF format; and
 - Audited Financial Statements, PDF format.

financial statements, Financial Reporting Form SR-1 and a certification as to the accuracy of the financials.

(Includes but is not limited to TCEP, MMRB, HC, EHCL, HOME, Viability, NHTF, and CDBG-DR.)

- DUE: Annually
 - TCEP: April 30th
 - MMRB, HC, EHCL, HOME, Viability, NHTF, and CDBG-DR: refer to the regulatory documents for due date.
 - All Group 2 programs: refer to the regulatory documents to determine when initial report is due.
- LATE FEE: Refer to regulatory documents for amount of late fee.
- ITEMS TO SUBMIT:
 - Parts 1, 2, and 5 of <u>Financial Reporting Form (SR-1) (Rev. 01/23)</u>, Excel format; Do NOT use older forms
 - Executed Certification, PDF format; and
 - Audited Financial Statements, PDF format.
