NOTICE OF INTERVENTION OF A SPECIFICALLY NAMED PARTY

Pursuant to rules 28-106.205 and 67-60.009, Florida Administrative Code, Intervenor Seventh Avenue II, Ltd. (Application No. 2015-171C) files this Notice of Intervention of a Specifically Named Party and states:

1. On May 22, 2015, Petitioner Coral Bay Cove, LLC (“Coral Bay”) filed a Formal Written Protest of Award concerning the proposed agency action of Florida Housing Finance Corporation (“FHFC”) in connection with Request of Applications (“RFA”) 2014-116, Housing Credit Financing for Affordable Housing Developments Located in Miami-Dade County.


2. Specifically, Coral Bay alleged in its petition that a development proposed by Intervenor, Seventh Avenue Transit Village II, was erroneously selected for funding by Florida Housing in connection with RFA 2014-116.

3. As a specifically named party in Coral Bay’s petition whose substantial interests will be determined in this proceeding, Seventh Avenue II, Ltd. is entitled to intervene in this proceeding as a matter of right. R. 28-106.205(3), Fla. Admin. Code.


