SP PRESERVATION'S NOTICE OF APPEARANCE AS A NAMED PARTY

SP Preservation II LLC ("SP Preservation"), pursuant to Rule 28-106.205(3), Florida Administrative Code, hereby enters this notice of appearance as a named party.

1. SP Preservation is the applicant for the Wedgewood Apartments project (Application No. 2015-254C), which is expressly named in the Formal Written Protest and Petition for Formal Administrative Proceedings ("Petition"). As explained in the Petition, SP Preservation was selected for funding. Petitioner alleges that it, rather than SP Preservation, would be funded if Petitioner is deemed eligible. Accordingly, SP Preservation's substantial interests will be adversely affected if the relief requested by Petitioner is granted.


