ORDER GRANTING WAIVER OF RULE 67-48.0072(26), FLA. ADMIN. CODE (06/23/2020)

THIS CAUSE came for consideration and final action before the Board of Directors of the Florida Housing Finance Corporation (the "Board") on May 10, 2024. On April 19, 2024, Florida Housing Finance Corporation ("Florida Housing") received a Petition for Waiver of 67-48.0072(26) (the "Petition") from Silver Lakes Village VOA Affordable Housing, LP (the "Petitioner") to extend Petitioner's loan closing deadline from April 30, 2024 to October 30, 2024. Notice of the Petition was published April 22, 2024, in Volume 50, Number 79, of the Florida Administrative Register. Florida Housing received no comments regarding the Petition. After careful review of the record and being otherwise fully advised on the premises, the Board hereby finds:

1. The Board has jurisdiction over the subject matter of this case and the parties hereto.

- 2. Petitioner has applied for funding to assist in the construction of Silver Lakes Village Apartments, a 104-unit development located in Orange County, Florida.
- 3. Rule 67-48.0072(26), Fla. Admin. Code (2020), states in relevant part:
 - (26) For SAIL, EHCL, and HOME, unless stated otherwise in a competitive solicitation, these Corporation loans and other mortgage loans related to the Development must close within 120 Calendar Days of the date of the firm loan commitment(s), unless the Development is a Tax-Exempt Bond-Financed Development which then the closing must occur within 180 Calendar Days of the firm loan commitment(s). Unless an extension is approved by the Board, failure to close the loan(s) by the specified deadline outlined above shall result in the firm loan commitment(s) being deemed void and the funds shall be de-obligated. Applicants may request one (1) extension of the loan closing deadline outlined above for a term of up to 90 Calendar Days. All extension requests must be submitted in writing to the program administrator and contain the specific reasons for requesting an extension and shall detail the time frame to close the loan. The Board shall consider the facts and circumstances of each Applicant's request, inclusive of the Applicant's ability to close within the extension term and any credit underwriting report, prior to determining whether to grant the requested extension. The Corporation shall charge an extension fee of one (1) percent of each Corporation loan amount if the Board approves the request to extend the loan closing deadline beyond the applicable 120 Calendar Day period outlined above. If an approved extension is utilized, Applicants must pay the extension fee not later than seven (7) Calendar Days after the original loan closing deadline. In the event the Corporation loan(s) does not close by the end of the extension period, the firm loan commitment(s) shall be deemed void and the funds shall be de-obligated.

- 4. Petitioner requests a waiver of the above rule to address delays caused Petitioner's need to complete the RAD program for the Section 202 PRAC conversion process with HUD.
- 5. The Board finds that granting the requested waiver will not impact other participants in funding programs administered by Florida Housing, nor will it detrimentally impact Florida Housing.
- 6. The Board also finds that Petitioner has demonstrated that the waiver is needed because of circumstances beyond its control and that it would suffer a substantial hardship if the waiver is not granted.
- 7. The Board further finds that Petitioner has also demonstrated that the purpose of the underlying statute, which is to "encourage development of low-income housing in the state," would still be achieved if the waiver is granted. §420.5099, Fla. Stat.

IT IS THEREFORE ORDERED that Petitioner's request for a waiver of Rule 67-48.0072(26), Fla. Admin. Code (6/23/20), is hereby **GRANTED** to allow Petitioner to extend its loan closing deadline from April 30, 2024 to October 30, 2024.
