### **Note Regarding 2020 Proposed RECAP Designations:**

The race and ethnicity data in the 2016 American Community Survey 5-year estimates have many high margin of error values. As a result, Florida Housing has excluded these variables for numerous census tracts using the same methodology as 2019. Although poverty remains near its peak level overall, it has declined slightly in high incidence tracts. The convergence of these two trends leads to fewer RECAPs in 2020 than there were in 2019.

In 2019 there were 73 RECAPs. Of those, 54 remain RECAPs in 2020. Among the 19 tracts which dropped out, 3 ( $\approx$ 15%) dropped due to data reliability, 1 ( $\approx$ 5%) dropped because of a decline in minority population and 16 ( $\approx$ 80%) dropped because of declines in poverty levels.

There are also 9 new tracts which meet the RECAP criteria in the updated dataset which were not RECAPs in 2019. They are all solidly minority-majority tracts that appear to have had marginal increases in poverty and the minority population which put them over the threshold. Overall, there are 14% fewer RECAP tracts in 2020 than in 2019.
