Subject: Comment on draft Rule Chapters 67-21, 67-48 and 67-60

The draft rules propose the following language as it relates to General Contractor requirements.

(f) Ensure that no construction or inspection work that is normally performed by subcontractors is performed by the General Contractor, apart from the General Contractor's duties to manage and control the construction of the Development, except that the General Contractor may self-perform work of a de minimis amount, defined for purposes of this paragraph as the lesser of \$100,000 or 5 percent of the construction contract;

We recommend removal of the \$100,000 dollar limit as highlighted above. The goal is for the cap to be a di minimis amount of work. Less than 5% of a contract is di minimis no matter how much the nominal value of the contract is.
