The purpose of using these forms (or alternatives drafted by FHFC) is to ensure that local governments and applicants have certainty that only 1 development qualifies for the LGAO designation. Without the use of LGAO specific forms, applicants could include FHFC's current local government funding forms in a 9% HC application seeking LGAO designation, notwithstanding the fact that the local government may be seeking LGAO designation for another development that is submitted in the same FHFC RFA.
