**FINAL ORDER**

This cause came before the Board of Directors of the Florida Housing Finance Corporation (“Board”) for consideration and final agency action on September 21, 2007. On or before February 16, 2005, We Help Community Development Corporation (“Petitioner”) submitted its 2007 Universal Cycle Application (“Application”) to Florida Housing Finance Corporation (“Florida Housing”) to compete for funding/allocation from the Home Program. Petitioner timely filed its Petition for Reconsideration, pursuant to Sections 120.569 and 120.57(2), Florida Statutes, (the “Petition”) challenging Florida Housing’s scoring on parts of the Application. Florida Housing reviewed the Petition pursuant to Section 120.569(2)(c), Florida Statutes, and determined that the Petition did not raise disputed issues of material fact. The Petitioner submitted a Notice of Voluntary Dismissal on August 17, 2007. The Hearing Officer issued a Recommended Order on August 20, 2007. A true and correct copy of the Recommended Order is attached hereto as “Exhibit A.” The Hearing Officer recommended Florida Housing enter a Final Order cancelling the informal hearing on August 28, 2007 and closing the file.


