The Verandas of Punta Gorda, LLP, was a Petitioner in the Second Amended Petition styled Westmont Park Partners, LP; The Verandas of Punta Gorda, LLP; and Janie Poe Associates 3, LLC, a case designated as FHFC Case No. 2010-019C and assigned to the undersigned Informal Hearing Officer. Prior to the informal hearing, the Respondent, Florida Housing Finance Corporation, filed a Motion to Dismiss The Verandas on the ground that it lacked standing to request an administrative hearing. At the commencement of the informal hearing, the parties presented oral argument on the Motion to Dismiss The Verandas as a Petitioner. FHFC Case No. 2010-019C is closed only with respect to the Petitioner The Verandas of Punta Gorda, LLP (FHFP Application Number 2009-015C).
