Petitioner, DELMAR TERRACE SOUTH, LLC, hereby Amends its Petition for Waiver of Rule Adopted RFA Provision to Allow Additional Extension of SAIL Loan Closing, and Variance to Rule 67-48.0072(15) to Allow Surety Bond, and Rule-Adopted QAP Provision on Placed in Service Dates, which was electronically filed on October 11, 2017, and assigned FHFC Case No. 2017-073VW.

Petitioner withdraws the following variance requests from consideration by the Florida Housing Finance Corporation Board of Directors:

- 1. A variance from Rule 67-48.0072(15) to allow alternate forms of construction completion guarantees.
- 2. A variance from the Qualified Allocation Plan, adopted and incorporated by reference in Rule 67-48.0072(95), Fla. Admin. Code, concerning the Placed in Service deadline for the proposed Development.

Petitioner expressly does <u>not</u> withdraw its request for a waiver of Rules 67-48.0072(4)(c) and 67-48.0072(27), incorporating by reference the terms and provisions of RFA 2014-115 so as to apparently limit an Applicant to a single 12 month extension of its SAIL closing date. Petitioner still seeks to extend its SAIL closing deadline by approximately 90 days, from November 2, 2017 to January 31, 2018.
